**Emergency & First Aid Procedures:**

<b>Eyes:</b>	Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses. Call a poison control center or doctor for treatment advice.
<b>Skin:</b>	Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Call a poison control center or doctor for treatment advice. wash contaminated clothing before reuse. Destroy contaminated shoes.
<b>Ingestion:</b>	Call a poison control center or doctor immediately for treatment advice. Do not induce vomiting. Drink one or two glasses of water to dilute product. Do not give anything by mouth to an unconscious person.
<b>Inhalation:</b>	In case of respiratory irritation or dizziness; move person to fresh air. If not breathing; give artificial respiration. If breathing is difficult; give oxygen. Call a poison control center or doctor for treatment advice.
